### Message from Red Lake Fire Service **Heating Safety**



Please make sure fuel-burning equipment is vented to the outside to avoid carbon monoxide (CO) poisoning. Carbon monoxide is created when fuels burn incompletely. Carbon monoxide poisoning can cause illness and even death. Make sure the venting for exhaust is kept clear and unobstructed. This includes removal of snow and ice and other debris around the outlet to the outside.

### **PURPOSE AND EFFECT:**


Request relief from Section 3.26(g) to reduce the waterfront setback from 30 m to 20m and 9.2 of the Zoning By-Law to reduce the minimum front yard setback from 10 metres to 0 metres. Permitting a recreational residence to be built no closer than 20m from the high water mark.




