Multi-Purpose Trail

You may have noticed work being completed on the newly constructed multi-purpose trail between Red Lake District High School and Hughes Crescent. We are excited to advise that this trail will be paved in September 2023 with resting benches and lighting to be installed thereafter. This trail is certainly a welcome addition to the entrance of our community and we are very proud to be able to provide a safe means of active transportation within our community. We will continue to expand on this trail system as funding opportunities become available.

New Cross Walk

In addition to construction on the new trail, you may have noticed work being completed at the entrance to Phillip Thomas Vinet Centennial Park and Young Street. This construction is necessary as MTO will be installing a cross walk in this location. This cross walk is a welcome addition to this busy area allowing for safe pedestrian crossing on Highway 105 to and from the park.

Updates to Bill Payment Methods

We are now offering easier ways to make payments! We can now accept E-transfers and Pre-Authorized Payments (PAP) as bill payment options.

Other payments methods accepted (at no cost) are: cash, cheque, debit, online bill payments and payment at most Canadian Financial Institutions.

We continue to accept credit card payments, however, please note as of August 1, 2023 a 2.75% surcharge will be added to all credit card payments. This surcharge is necessary due to the increasing cost of credit card processing fees.

Hydrant Flushing

Please be advised that hydrant and water distribution system flushing within the of Red communities Lake. Balmertown. Cochenour, McKenzie Island and Madsen will begin on September 5, 2023 for approximately 8 weeks. During the flushing process, there should be no interruptions to water service. Common and temporary effects of the flushing process include a slight drop in water pressure and/or cloudy/discoloured water.

There are no health risks with using the water. However, household cleaning, laundry and food preparation should be postponed while local flushing is being completed. Upon completion, consumers should open a cold water tap for a few minutes until the water appears clear.

Feeding of Wildlife

Reminder to ensure all food products/scraps, garbage, pet food, fish guts and bird seed is properly stored to minimize wildlife encounters.

Do not use municipal garbage cans to dispose of fish guts or any other household garbage as it can attract animals to these public areas.

There is a minimum fine of \$300 under By-Law No. 41-2015 for intentionally feeding wildlife, which includes illegal dumping of fish guts and household waste.

In case of emergency regarding dangerous wildlife encounters call 911. If it is a nonemergency Bear encounter call the Bear Wise reporting line at 1-866-514-2327.
