At the date and location below, the Municipality of Red Lake Committee of Adjustment will be hearing comments on an application for Minor Variance, described as follows.

LOCATION AND PROPERTY DESCRIPTION:

Part 1 Plan 23R-10871 (Hwy 105, Red Lake). Please refer to the location sketch below.

PURPOSE AND EFFECT:

Request relief from requirements of the Zoning By-Law: Section 12.2 reduced minimum lot frontage; Section 3.2(c) permit accessory buildings in the front yard; and Section 3.29(a) interim relief of street frontage requirements until the new road is surveyed and assumed by By-Law.

OTHER APPLICATIONS:

An application for Site Plan Approval has been submitted for the subject property.

ADDITIONAL INFORMATION: Complete application for the proposed Minor Variance is available for inspection at the Municipal Office.

PUBLIC HEARING: You are entitled to attend the public hearing in person to express your views about this application or you may submit written comments to be read by the Committee at the hearing. FAILURE TO ATTEND HEARING: If you do not attend the hearing it may proceed in your absence and, except as otherwise provided in the *Planning Act*, you will not be entitled to any further notice in the proceedings.

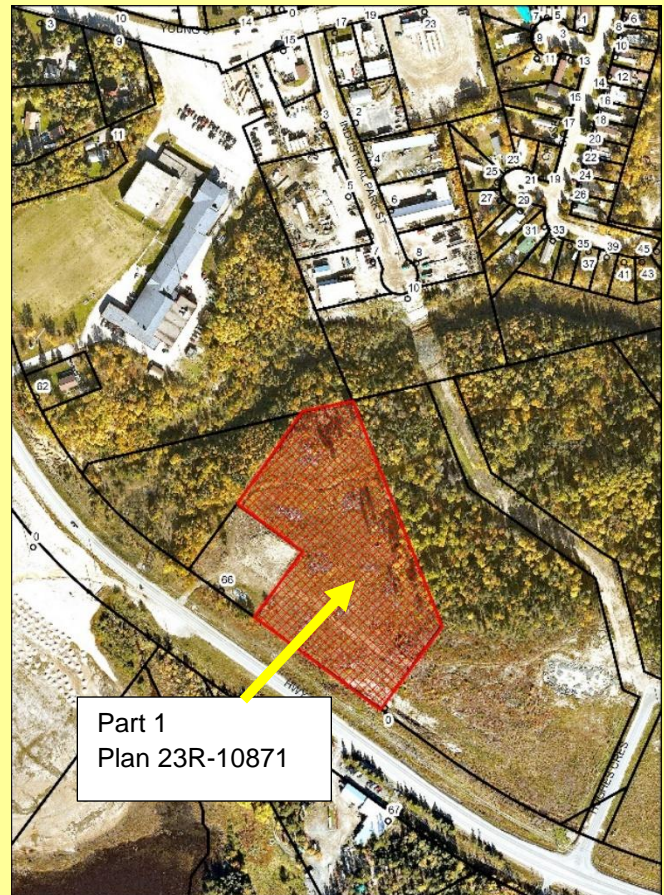

TAKE NOTICE that the Council of The Corporation of the Municipality of Red Lake has received a complete application for the Consent to Sever described as follows:

LOCATION OF PROPERTY: 23R-4435 Parts 4 & 5 known as 341 & 343 Howey Street (Highway 618), Red Lake, refer to the location sketch.

PROPERTY DESCRIPTION: The subject property is designated Townsite Residential and zoned Townsite Residential Density 1 (R1). Parts 4 & 5 are developed with dwelling units and were inadvertently merged.

PURPOSE AND EFFECT OF APPLICATION: To receive Planning Act Consent to sever property, having the effect of creating one (1) retained lot and creating one (1) new lot, reverting to original individual lots which comply with the Zoning By-Law and Official Plan requirements.
